Applicable Films: Seattle Filmworks; Signature Color; Eastman 5247 or 5294; Kodak Vision 2 or 3 500T / 5218 or 7218.

Service Time: One to two weeks in lab.

Choose Matte or Glossy, 4x6 or 3½x5. Kodak Royal Paper. The default service is 4x6 Matte prints (if you don't specify).

**Minimum charge:** \$9.95 "Develop Only" service (blank rolls)
